Anna Allott also just completed a translation of the Burmese konbaungzet chronicle dealing with the 1824-26 Anglo-Burmese war and the Treaty
of Yardabo. It is a teaching text intended for aiding those who want to learn
to read chronicle Burmese. The manuscript of 60 pp. may be published soon and
Anna is willing to provide interested individuals with a copy. It contains
the Burmese text and English translation on facing pages, beautifully printed
in Okell's Burmese font. Anna Allott also reported that the new BurmeseEnglish dictionary produced by the Burmese Language Commission was finally
published in Rangoon in August.

Sandra Dudley, currently at the Smithsonian Institution's National Museum of Natural History, recently completed her M. Phil. in Ethnology and Museum Ethnography at the University of Oxford. The culmination of two years' work at Oxford, the thesis is entitled "Interactions: Approaches to Burmese Buddhism and the Nat-cultus".

News from the Britain-Burma Society:

The Britain-Burma Society regularly sponsors public lectures and meetings about Burma. It also publishes a newsletter from which the following schedule of presentations has been taken:

a talk with slides on Paw Oo Thet--The Artist--his life, his work and his paintings--by Dr. Sun Myint on 2nd December 1993.

The media in Myanmar Naingngan--what the Burmese can See, Read, and Hear--by Vicky Bowman--2nd November, 1993.

Vicky Bowman has recently returned from three years in the British Embassy in Rangoon. Despite censorship, Burma is gradually becoming part of the "global village". She discussed the sorts of magazines and books and the types of programs that the Burmese can--and want to--read and watch, and how their contents have been affected by censorship.

Tourism in Burma Today--getting off the beaten track--by Nicholas Greenwood, 16 June 1993.

(Econ), London, Ph.D. (Cambridge), currently Rector of the Institute of Economics, Yangon.

It shows us buildings and places which have long since been destroyed, such as the Royal Palace at Mandalay or King Tharawaddy's great elephant stockade at Amarapura, and at the same time reveals how many traditional aspects of life in Burma are still essentially unchanged today. This remarkable collection of Buddhist sculpture was shown in exhibition in Spring 1993 by the Tasei Gallery in Singapore. All of the eighty-four pieces -- bronze and stone Buddha images, gold repousse votive plaques, terracotta votive plaques, and glazed Jataka tiles -- are said to have been found in Burma. This includes some pieces originally from Sri Lanka, India, Cambodia, and Thailand.

The exhibition raises many questions. How the many ancient objects arrived on the world market is a nagging worry. Some of the attributions are puzzling. For instance, items 1 and 2, labelled "Pyu", are described as such because of over-large hands with webbed fingers. Yet this is a characteristic of Mon-Dvaravati images in Thailand. Also, a troubling number of images are identified as Arakan influenced by Shan, a difficult concept. The descriptions of mudras show a Thai bias; the double abhaya mudra is referred to as "restraining the waters", a uniquely Thai interpretation.

Nevertheless, the collection is of outstanding interest and many of the images and objects are staggeringly beautiful. Probably the single most beautiful piece is No. 63, a late Pagan period gold repousse plaque of a seated Earth-touching Buddha with two monk attendants and two flying celestials. (This piece was offered earlier in a Tasei Gallery auction in New York in 1992.) Of special interest is another gold repousse plaque, eighthcentury Pyu, of the Buddha seated in meditation (No. 41). Both of these pieces are in near-perfect condition. Such gold repousse plaques have come into the market during the last eight or nine years and seem to represent Pyu, Mon, and Khmer types. Shown in the exhibition catalogue are 22 examples.

The bronze images range from "provincial" to classical. An Arakanese "Yung-Lo" style image is most impressive -- crowned and bejewelled with two

attendants, he is nevertheless a serene presence (No. 27). Another bronze, which appears to be a classic early Pagan-type standing image, looks remarkably fine (No. 39). However, it is described as 150-200 years old according to test results. This is impossible - it must be either eleventh century or a contemporary copy.

The terracotta votive tablets, 13 examples, appear to be rather worn, but this may well be a photographic problem rather than the actual condition of the objects. Two Pagan votive plaques are outstanding: No. 77 showing the Buddha seated in "European style" surrounded by stupas and with Nagari script below; and No. 77, showing the Earth-touching Buddha with standing Buddhas on either side. The three stone pieces are fine examples, although No. 67, a sensitive depiction, is probably misidentified; it is called "late Pagan", but looks Mon in both its proportions and facial type.

Though we are left aching to know the provenance of each of these interesting pieces, we must praise Tasei Gallery for providing this catalogue with so many examples of Buddhist art found in Burma. It is a contribution toward our knowledge in this all-too-unexplored field.

1993 The Life of the Buddha, San Francisco: Pomegranate Art Books in association with the British Library; hardcover, ISBN 1-56640-602-1, 95 pp.; 62 full-color reproductions; 16 black and white illustrations; \$25.00.

In this attractive publication, Patricia Herbert introduces a general readership to the art of Burmese painted manuscripts. The volume was compiled and published in conjunction with an exhibit of Henry Burney's collection of painted manuscripts acquired from Burney's descendants by the British Library in 1985. However, this impressive book conveys more to its readers than catalogues of exhibits usually do.

The main sections of the volume reproduce most of the panels of two brilliantly colored white painted parabaiks (OR. 14297 and OR. 14298) that depicts thematically condensed scenes taken primarily from the last life of Gautama Buddha as Prince Siddhartha and also later ones during his ministry that followed his enlightenment. These artistic representations are in the Mandalay style of the late 19th century and are accompanied by English translations of the condensed Burmese text that refers to and explains the scenes depicted. Particularly noteworthy is the quality in which the originals have been preserved as well as the quality of their reproduction in the printed format which is large enough to show the drawings in considerable detail.

These two manuscripts are part of a larger collection collected by the British diplomat Henry Burney (1792-1845) who served from 1830 to 1837 as British Resident to the Court of Ava. Scholars of Burma may be particularly interested in learning that the provenance of the painted manuscript in independently confirmed by some 30 pages of notes in Burney's handwriting also preserved in the British Library which comment primarily on the life of the Buddha as portrayed in these painted parabaiks. Herbert has added a useful introduction to these reproductions in which she takes the general reader through significant themes in the last life of the Buddha and briefly discusses Buddhist history, lists some of the major Theravāda texts, and defines central concepts of Buddhist belief. She then focuses Buddhist art and Burmese manuscripts and gives a short summary of the context of Burney's

residence at Ava. In the Appendix (pp.81-93), she provides further brief identification and summaries of the scenes depicted in the concertina style format of the manuscripts. The Glossary contains explication of Pāli names, and where appropriate, their Burmese equivalents.

As a scholar of Burmese Buddhism, I would have liked to see more discussion of the religious biography in Burmese Buddhism and a bibliography of relevant works on the subject. However, the purpose of this publication was to feature the arts, religion, and manuscripts of Burma. In this regard, the book is a laudable effort to bring greater prominence and increased public awareness to both.

Curiosity about nats has motivated non-Burmese for centuries. This book by a French ambassador joins a rather small group of works in English on nats. Originally written in French, the book was translated into English by Roser Flotats.

Profusely embellished with superb large color photographs and rather-too-small black and whites, this short work seems to have been written as a by-product of the author's dedication to making films of nat festivals, which he, unlike many Westerners, had the diplomatic opportunity to travel to see and record. The emphasis, then, upon nat stories, natkadaws, and rituals is not surprising from a film-maker author.

A nod or two is given to those who have come before, such as Temple, Htin Aung, and Spiro, but this is not a scholarly book. There are no footnotes, although there is a small bibliography that includes a few Burmese works. Many standard references are missing, such as Mendelson's articles. Inclusion of footnotes would have made clear where (other than in The Glass Palace Chronicle) the author found the nat stories that clearly fascinate him.

The part of the book most interesting to the reviewer was the section on the festivals as they are found in modern Burma. An expansion of that material would have been most welcome, as would have been more details on the individuals the author became familiar with as natkadaws. In other words, this reader feels the author knows much more ethnographic detail than the book reveals. Historical changes are mentioned in nat popularity and festivals, all very interesting, but the treatment is rather meager. The pan-Burma scope of the book is admirable and gives the work importance.

The author employs a nice, non-judgmental way of presenting his material, but the Burmese supernatural is a complex problem in cross-cultural understanding that cannot be handled properly with just a few sentences on Melford Spiro. However, the book does not set out to be theoretical. Its value is found in its exuberant photographs and in the first-hand observations of the author. Most Burma Studies Group members will probably want this modest volume in their library.

Burma News on Electronic Nets:

Bibliography - Books and Articles on Burma:

This bibliography is an attempt to bring together all current articles and books on Burma in English and other European languages. The first installment of this bibliography appeared in Bulletin of Burma Studies Group no. 48, August 15, 1992, the second in no. 49, January 1993 and the third in no. 50, Summer 1993. This is the fourth installment in the series. Future installments will be numbered consecutively.

The following procedure is being used to compile this bibliography. Articles on Burma are downloaded on to a disk from the H.W. Wilson CD-Rom Humanities and Social Sciences indices, which are updated monthly. Then, articles from journals published in Southeast Asian countries which are not included in the above databases are added to the bibliography. Monograph lists are taken from the NIU Southeast Asia Collection development (acquisition) files. The arrangement of entries is alphabetical by author (usually last name) or title (in absence of an author). Burmese and Thai names are alphabetized in direct written order. For example, the Burmese names "Mya Than" and "Aung San Suu Kyi" would be listed under "Mya" and "Aung," respectively; the Thai name, "Sulak Sivaraksa" under "Sulak."
